Detailed description of content	<p>The course is based on recent theories about the company's development, innovation and value creation in the light of its resources and surroundings. We focus on how modern companies and organizations use resources to create value. Value creation can be seen from different perspectives, where managers, employees, users and others can have varied interests in what value is created and for whom. In the course we work with an analysis of how different types of resources are involved in the creation of value, eg employees, users, knowledge resources and network resources, and we also focus on different ways of mobilizing resources.</p>

Overall content	The course is composed of two parts. One part of the course provides the students with an overview of recent perspectives on how businesses and organisations can work with their resources, value creation and innovation. The other part of the course is a seminar wherein the students will work in a seminar setting that includes a presentation of theories and observation of cases and the writing of an essay dealing with a research question of their own choosing. The students must select an analytical perspective to write an essay about.
Teaching and working methods	A number of lectures lasting 2-4 hours and some associated exercises (workshops). There will also be a number of seminars lasting 2-4 hours.
